Agreement for BOC Visa Electron Debit Card Terms and Conditions

Bank of Ceylon

Dear Sir,/Madam/s

I,

authorize and request you to issue me the BOC Visa Electron Debit Card and hereby agree to be bound by the following terms and conditions.

1. The BOC Visa Electron Debit Card shall at all times remain the property of Bank of Ceylon and shall be returned to the Bank unconditionally and immediately upon the Bank's request.
2. BOC Visa Electron Debit Card is for my own personal use only. It is not transferable. It shall not be used for any purpose other than for transactions designated by the Bank.
3. I shall keep my personal Identification Number (PIN) strictly confidential and undertake not to reveal such number to any person at any time or under any circumstances. In respect of BOC Visa Electron Debit Card PIN shall mean the original Personal Identification Number confidentially generated for me by the Bank and any substitution effected by me.
4. I shall accept full responsibility for all transactions processed or effected by the use of the BOC Visa Electron Debit Card however effected.
5. I hereby authorize you to debit my account with the amount of any withdrawal / transfer payment made by the use of the BOC Visa Electron Debit Card.
6. I further authorize you to debit my account with all charges relating to transactions made internationally through BOC Visa Electron Card or through any other Local Networks except the Bank's network, wherever applicable and also with any other liabilities inclusive of legal fee or other statutory charges if any, relating to the use of BOC Visa Electron Debit Card.
7. If my account is a joint account, I shall be jointly and severally liable for all transactions arising from the use of the BOC Visa Electron Debit Card.
8. I shall accept the Bank's records and statements of all transactions processed by the BOC Visa Electron Debit Card as conclusive and binding on me for all purposes.
